Over 91 Mile Travel Range Game Fee & Mileage:

A) All members of the officiating crew will receive the base game fee. Officials will be reimbursed portal to portal (round-trip travel from official's home address to venue address) one car at state rate (65.5 cents per mile), two cars at 75% of the state rate, or three cars at 60% of the state rate. Rates based on the state rate as of August 1st.
B) A \$15.00 riders fee will be paid for contests over the 91-mile range.
C) Meals will be paid at \$15 during regular season games and \$30 for travel over 91.
D) By prior agreement between officials and school authorities, airfare may be

substituted for automobile travel fee.
